UNITED SOCIETY *US*
OUR **CODE OF ETHICS** FOR ALL OF *US*

This code is based on the Western Australia Public Sector Standards Commission.

A) JUSTICE

INTENT: Fairness and equality, use and share power for the common good, take non-discriminatory action.

APPLYING THIS PRINCIPLE MEANS:

- * Using and sharing power for the common good of both the individual and society.
- * To be a fair law for **ALL** people, no special protecting conditions are made for professionals or government seniors. All people will be entitled to their **HUMAN RIGHTS** and have **EQUAL OPPORTUNITIES**.
- * Practicing universal fairness and equity.
- * Not treating people as a means to an end.
- * Not discriminating against, abusing or exploiting people in any way. To treat others as one would want oneself treated.

B) RESPECT FOR PERSONS

INTENT: Respect **ALL** the rights of others and act to empower others to claim their rights as humans.

APPLYING THIS PRINCIPLE MEANS:

- * Enabling or empowering others to achieve their potential so people behave on the highest level of self-confidence and self-esteem with high self-worth.
- * Promoting the physical, mental, emotional, Spiritual and social well-being of others.
- * Being totally truthful, trustworthy and sincere when dealing with others.
- * Showing sensitivity, consideration and compassion to others.
- * Respecting the rights of individuals and groups and their right to be different and have freedom of speech.
- * Respecting and encouraging our Human Rights to believe in anything, no matter how bizarre, as long as we do not force our beliefs on anyone or cause a disturbance, breaking laws.

- * Ensuring we do not use our position for personal gain to feather our own nest.
- * Being prepared to share our blessings and misfortunes.

C) RESPONSIBLE CARE

INTENT: Contribute to the well-being of individuals and the common good of society. Help others less fortunate than ourselves.

APPLYING THIS PRINCIPLE MEANS:

- * Doing good and not doing harm.
- * Exercising our duty of care.
- * Loving and respecting yourself so in turn you can for others.
- * Treating others as you and they would like to be treated.
- * Protecting the state's resources.
- * Upholding the rights of those who are unable to do so.
- * Advocating for others where required.
- * Acknowledge **ALL** people in a loving, friendly manner; don't forget the occasional "G'day mate."

D) FAMILY CODE

INTENT: Just for today may we practice love, peace and forgiveness in all that we do for both ourselves and others.

APPLYING THIS PRINCIPLE MEANS:

- * Just for today do not worry.
- * Just for today do not be angry.
- * Honour your parents, teachers and elders.
- * Earn your living honestly.
- * Show gratitude to every living thing.

OUR FOUNDATION

OUR MORALS, VALUES, BEHAVIOURS

Based on the loving, good, positive teachings from various religions, formal and non-formal.

In order to meet the requirements of the ethical principles of **JUSTICE, RESPECT FOR PERSONS, RESPONSIBLE CARE** and **FAMILY CODE**, we have the responsibility to comply with the following morals, values and behaviours (refer to section on **CODE OF ETHICS**):

A) JUSTICE –

1. FAIRNESS & EQUITY:

We all have a responsibility to:

- * Act impartially to serve the common good, while recognising that equity can involve treating people differently according to their circumstances.
- * Practice universal fairness and protect people's rights to due process, equal opportunities and equitable outcomes.
- * Develop and maintain an environment that is free of fear or favour and is open, accountable and impartial.
- * Provide for advocacy and fair resolution of grievances and complaints brought by employees and public.

2. LAWFUL OBEDIENCE:

We all have a responsibility to:

- * Uphold the laws of the Commonwealth of Australia and the State.
- * Faithfully and impartially carry out lawful decisions and policies.

B) RESPECT FOR PERSONS –

1. HONESTY:

We all have a responsibility to:

- * Behave honestly in all our dealings.
- * Openly declare matters of private interest that may conflict with the performance of our public duty.
- * Ensure we do not use our position for personal profit or gain.

2. OPENNESS:

We all have a responsibility to:

- * Be open about the decisions and actions we take and the reasons for these decisions and actions.
- * Recognise that others have a right to know about decisions and actions that affect them.
- * Provide information that enables people to make informed decisions themselves.

3. RESPECT:

We **ALL** have a responsibility to respect a person's right to:

- * Courtesy, consideration and sensitivity in all their dealings.
- * Quality service.
- * Privacy and the confidentiality of records.
- * Seek independent advice and support, where needed to protect their entitlements.
- * Have their complaints heard, listened and responded to promptly.

4. LOYALTY:

We all have a responsibility to:-

- * Impartially carry out our duties and be loyal to the public, our employer and to each other, without compromising integrity.

5. INTEGRITY:

We all have a responsibility to:

- * Behave in a consistently ethical, competent and reliable manner.
- * Avoid making commitments that may bias our judgment or compromise the performance of our public duties.
- * Disclose fraud, corruption and mal-administration to an appropriate authority.
- * Provide impartial advice to our employer that represents our best understanding of the public interest.

C) RESPONSIBLE CARE –

1. PROTECTIVE CARE:

We have a responsibility to:

- * Exercise a duty of care to the public, to do good to others and to ensure that any potential harm is minimised.
- * Uphold the interest of all, including those at risk in the community with respect to services provided.
- * Manage the resources and assets of the State of WA for the benefit of future generations.

2) EFFICIENCY:

We all have a responsibility to:

- * Ensure the efficient and effective use of those resources to minimise costs and avoid waste.
- * Be publicly accountable for the use of those resources.

3) PERSONAL DEVELOPMENT:

We **ALL** have a responsibility to:

- * Use initiative and be responsible for what we do.
- * Strive for excellence.
- * Participate in teamwork, if required.
- * Maintain our level of competence related to our agency's responsibilities.

4) LEADERSHIP:

Public leaders and managers have a responsibility to:

- * Consult with peers, employers and general public.
- * Lead by example.
- * Establish processes that support and monitor ethical behaviour.
- * Help others to reach their potential.
- * Consider the potential impact of decisions on colleagues and the community.

D) FAMILY CODE –

1. DAILY PRACTICES:

- * To take the theme of Love, Live, Model it, so we will become IT.
- * In doing so we need to express the following 13 Aspects (inter-relating) in our daily practices – Care, Concern, Compassion, Understanding, Empathy, Consideration, Friendship, Sharing, Kindness, Service, Cooperation, Passion and ONENESS.
- * Aim to break the separation we have inherited or set upon ourselves and unite in true Brotherhood and Sisterhood to realise that the essence of each of *US* is the same— we are ONE.
- * You are me, I am you – why is that such a mystery?

I returned to Western Australia from Tasmania in 1998 and connected with Alan from the Peace Shield Foundation, through which he had formed a political arm to which I amalgamated US. We named the political arm the World Freedom Party and decided to changed Peace Shield to World Focus. World Focus is a complete alternative to the New World Order. I will now share with you Alan's initial World Freedom Party manifesto before we aligned:

The current economic system is undergoing dramatic multi-directional changes which are affecting everyone from millionaires to the poor and are being brought about to facilitate a coercive way of controlling the peoples of the world.

Most of the grassroots organisations are aware of the inadequacies of our established system of practices, but hardly any of them have a real understanding of how the world management system is structured and how this structure is gradually stifling the civil liberties that are so essential to our spiritual well-being.

The mechanisms which can make possible the management of the peoples of the world are already in place and are now being used by the de facto World government or New World Order. The missing piece is the legality of its operation; it has the power and is using it, but, in order to enforce its actions, it will have to operate openly by obtaining legal jurisdiction over the nations of the world. This will not be brought about by democratic means but by stealth. The key weapon it has in its immense armoury is the control of money.

The World Freedom Party is a new political party with the aim of replacing the current system by systematically dismantling centralised government and installing an alternative system, geared to meet the needs of the environment in harmony with society, and supported by a realistic ethical economy. A true democracy must sustain the ethics upon which it is founded with love and compassion. The greater the ethics the fewer laws society will need.

The World Council of Nations (W.C.N.)

Ostensibly, at this time in history, world affairs are discussed by national representatives in the United Nations and resolutions are made for subsequent actions to be taken. Five of the major powers have the right to veto any resolution to prevent its being passed. Those countries which do not have the right of veto now have the choice of resigning from the UN and becoming members of the World Council of Nations. W.C.N. is a legislative body based on ethical principles of real democracy. Each member country has one vote and no right of veto.

Once the constraints of governments which make them subservient to the de facto New World Order are removed, they will be free to plan and implement new ideas and clean technology for the benefit of society, thereby clearing the way for a new age of prosperity and spiritual fulfilment to emerge.

Over 15 years, the Peace Shield had developed through Alan (a.k.a. *Our **World Freedom Parties Alliance (W.F.P.A.)** represents US, the people of Australia and the world, as we come together through our own unique Individuality from various parties, groups and organisations etc, as a large, healthy family working together to reform the government(s), which have forgotten that they were elected to represent US and have become their government rather than ours, with a need to control US, which is enslaving US through the system and centralisation, globalisation into a world order, where we would lose our greatest God-given gift – Free Will. With the W.F.P.A. no person or elite group is to be in control; we are all the heads and the body of W.F.P.A., a True Democracy.*

We cannot do it alone. Society here and throughout the world has become drastically darker by the day. We cannot allow the two main worn-out political parties caught up in the system—inheriting each other's problems, bad habits and debts, and swamped by powerful international manipulators, led by oil (black gold), drugs and greed—to take US down the gurgler anymore. Such organisations as the UN, WTO, IMF, WHO and others have lost their initial good intentions and purposes to become big business operators that dictate rather than serve US.

Dear Sir,
